Entry Fee is \$20.00 per contestant. Make checks payable to Johnson County Fair Association.

Winners should be available during the week of the fair for various appearances and responsibilities.

#### Interview:

Interviews will be held July 15th from 9:30 AM - 12:00 Noon at the Johnson County Extension Office. Each interview will last 2 minutes.

Contestants will be judged based on conduct, personality, attentiveness, and responses to questions.

Contestants are asked to wear age appropriate attire, PLEASE NO long dresses or tuxedos.

## **Contest:**

The public contest will be held July 15th from 3:00 - 4:30 PM at the Johnson County Fairgrounds in the Indoor Arena. Line-up will be at 2:45 PM. Contestants may come early to practice.

Contestants will be judged based on poise, personality, and overall presentation.

Contestants MUST wear white or light colored shirt, shorts, white socks and tennis shoes. Please NO sandals.

Due to the limited amount of time, please no modeling routines, turns or poses.
