Entry Fee is \$25.00 per contestant. Make checks payable to Johnson County Fair Association.

Winners should be available during the week of the fair for various appearances and responsibilities.

Interview:

Interviews will be held July 14th from 9:00 AM - 12:00 Noon at the Johnson County Extension Office. Each interview will last 2 minutes.

Contestants will be judged based on conduct, personality, attentiveness, and responses to questions.

Contestants are asked to wear age appropriate attire, sundress, etc. **PLEASE NO** long dresses or tuxedos.

The public contest will be held July 14th from 3:00 - 4:30 PM at the Johnson County Fairgrounds in the Indoor Arena. Line-up will be at 2:45 PM. Contestants may come early to practice.
